# How do we identify children with SEND?

How does the school know if children need extra help and what should parents do if they think their child may have special educational needs?

• We have an open door policy at the school. If a parent is concerned about the progress their child is making they can initially speak to the child's class teacher or alternatively, they can arrange to meet with the Special Educational Needs Co-ordinator (SENDCo).



• Throughout the year class teachers and the senior leadership team monitor the progress of all children in the school. If a child is not making the expected progress they will be closely tracked and additional support implemented if required. Learners can fall behind for many different reasons, therefore only those with a learning difficulty which requires provision that is in addition to or different from the normal differentiated curriculum will be identified as having SEND.

### In England, the government defines special needs as:

A child has special educational needs if they have a learning problem or disability that make it more difficult for them to learn than most children their age. They may have problems with schoolwork, communication or behaviour. 'Special educational needs' is a legal definition and refers to children with learning problems or disabilities that make it harder for them to learn than most children the same age.

There are four main areas of Special Educational Need:

- cognition and learning
- communication and interaction
- social emotional mental health
- physical and sensory

At Garvestone all areas of need are supported through learning support aids, scaffolding and with the support of adults either in the classroom or leading interventions such as Dancing Bears, Plus 1, Talk Boost and Maths Mastery.

### **Garvestone SEND profile September 2023**

30% of pupils on roll at Garvestone Primary are identified as having SEND; 3% of Pupils have an Educational Health Care Plan.

Of this 30% of SEND it is divided into the following areas of primary need. Some pupils will have secondary needs also.

Communication and Interaction - 25%

Cognition and Learning - 65%

Social, Emotional and Mental Health - 5%

Sensory and Physical - 0%

### What we do to support learners with SEN:



How does the school support pupils with special educational needs?

- All teachers adapt the curriculum to ensure access to learning for all children in their class.
- When the school identifies the need for additional support to enable a pupil to make expected progress, the parents/carers will be invited to a meeting with the class teacher to discuss a plan of support.
- This support may include pre teaching opportunities, additional resources modelling language and behaviours, preparation for changes in routine or intervention.
- SEND support will use the <u>Assess, Plan, Do, Review model</u>.
- The school may also take advice from different professionals as to how we can best provide additional support for our children. Professional advice may involve internal staff (Head, SENDCo) as well as external staff (Speech Therapists, S2S Support, Educational Psychologists, Virtual Schools)

We have a School Provision Map that shows the range of additional support taking place in our school for children who require extra help in their learning. We modify the provision map regularly and it changes every year, as our learners and their needs change.









Ways we support our children with SEND. These were shared with parents at a SENDCo coffee morning recently. We have also held a SENDCo coffee morning with a focus on sleep and behaviour support.



### What support is in place for Social and Emotional Wellbeing?

- All pupils are supported with their social and emotional development through the curriculum and at playtimes.
- We follow the PATHS programme and the children have regular circle times around social themes.
- The school works with parents and children to encourage high levels of attendance.

The school also has a supportive and strong ethos and a positive approach to behaviour management is adopted. Reward systems such as stickers and Dojos encourage good behaviour are used within classes.







How we keep parents informed:

# How will parents know how their child is doing?

- Parents/Carers are invited to termly parent's evenings to discuss the achievements, progress and support that the school is providing and how they can help their child at home.
- In addition targets/ next steps will be set for the children following a discussion with the children and their parents.

  Parents/Carers and Children will also be involved in reviewing these targets at least termly.

If your child has an Education, Health and Care Plan (EHCP), a formal meeting will take place to discuss your child's progress annually in addition to the termly meeting.



How we evaluate the effectiveness of our provision:

How will we know if the provision for children with SEND is effective?

• Progress data of all learners is monitored by teachers and Governors. The SENDCo also collates impact data of interventions to ensure that interventions are proving effective.

#### **Provision and Services:**

When required specialist expertise can be drawn upon. Some services that have been involved with the school to date are:

- NHS Speech and Language Service
- School to School Support
- CAMHS (Child and Adolescent Mental Health Service)
- Educational Psychologist
- Sensory Support

How are pupils included in activities outside the classroom including trips?

- The school carries out risk assessments for all children including the children with SEND before attending a school trip.
- Parents or carers are consulted prior to a school trip and asked to attend if necessary.
- Consideration is made for how school trips can be adapted to assist the individual child. In the unlikely event that it is considered unsafe for a student to take part in an activity, then alternative activities will be provided in school.
- The <u>accessibility plan</u> is also outlines this further.

# **Staff Training**

What training have the staff supporting pupils with SEN had, or what are they expected to have?

The school is committed to further developing the skills and knowledge of the staff supporting children with SEND.

- Recent training includes:
- Sensory Support (to support children with hearing impairments)
- PATHS training
- Struggling readers and writers training
- National Award for SENCO's
- Speech and Communication training
- Dyslexia training
- ASD training
- Auditory Processing Disorder training
- Number Stacks training
- Concrete Pictorial Abstract Maths training

#### **Transitions**

- How does the school prepare and support pupils to join the school, transfer to a new school or the next stage of education and life in order to ensure their wellbeing? Before children start in Reception they are offered three half day visits to meet their new teacher, teaching assistant and become more familiar with the setting.
- When joining our school from another school or nursery the class teacher/SENDCo will ensure they have read the child's file and any reports from the previous setting and if appropriate will discuss the child's needs with the previous school or setting. They will also liaise with parents to ensure the transfer to the school is as smooth as possible.
- When a child with special educational needs is moving to a new school, transition meetings/conversations will take place with the class teacher and SENDCo of our school and the new school. The individual needs of the child will be discussed as well as ways to make the transition as smooth as possible for the child. These ideas and meetings will also be shared with parents.
- The types of provision we put in place to ensure a smooth transition and support our children when they are moving school are things such as extra class visits, social stories, taking photographs of the new staff, transition books and the children's confidential files will be forwarded to the new school setting. The files contain educational information about the child which supports a smooth transition for the child as well as a continuous education from one school to another.
- Transition to secondary school will be discussed during Year 5, to ensure time for planning and preparation where appropriate.
